- ✓ the possibility of implementation in the test instance without the use of HSM and in the production instance with the use of HSM
- ✓ support for all modern and safe algorithms recommended by eIDAS (SHA-256 / SHA-512 hash functions and RSA keys with a length of 2048/4096/8192 bits)
- ✓ automatic support for the repository of certificates, CRL lists, OCSP services and TSA time stamping
- ✓ possibility of working in increased security mode (off-line mode)
- ✓ working with clusters of HSM devices to achieve high availability (HA) and scaling performance
- ✓ a license that allows utilization by an unlimited number of users, systems, certificates and certification authorities
- ✓ a license that allows the support of all encryption key lengths supported by HSM
- ✓ full respect of the planning, installation, commissioning and operation procedures required for the certification center.

#### The provision of CinemaVision CA services is based on:

  - Certification Practice Statement (CPS)

- ✓ **OCSP** — used internally by the online service, to sign responses to requests for certificate status
- ✓ **Personal** — for signing and encrypting data sent electronically, mainly by e-mail, for system access authorization and customer authentication in SSL connections
- ✓ **Code signing** — for confirming the identity of network routers. It allows you to create virtual private networks by setting up encrypted connections
- ✓ **IPsec** — for confirming the identity of routers in both local and internet networks. It allows you to create virtual private networks by setting up encrypted connections
- ✓ **SSL** — for securing web servers and confirming their authenticity. It allows you to set up an encrypted SSL connection between certificate servers and clients and to provide secure login to services.
